1. Creating an Account

Step 1: Register

1. Visit the Cambodia Law Box website.
2. Click **Sign Up**.
3. Complete the registration form with:
 - Full Name
 - Email
 - Occupation (Optional)
 - Organization (Optional)
 - Address (Optional)
 - Mobile (Optional)
 - Username
 - Password
 - Subscription Plan: Free Trial (7 days), 1 Month (\$4) or 1 Year (\$40)
4. Submit the registration form.

Step 2: Verify Your Email

1. Check your email inbox for a verification email.
2. Click the verification link provided.
3. Your email address will be verified successfully.

Step 3: Subscription Activation

- If your selected plan requires payment, submit your payment receipt as instructed.
- Your subscription will remain pending until payment is verified by the administrator.
- Account activation may take up to 24 hours after receipt validation.

1. Click **Login** on the homepage.
2. Enter your registered email address or username and password.
3. Click **Sign In**.

- Use specific legal terms for more accurate results.
- Search by:
 - Legislation or regulation title
 - Legislation or regulation number
 - Legislation or regulations contents
 - Subject matter
 - Keywords

Filtering Results

You may filter results by:

- Legislations or regulations Type
- Subject Area
- Language

4. Accessing Legal Documents

1. Select a document from the search results.
2. View the document online.
3. Navigate through chapters and articles using the document menu.
4. Use the search function within the document to locate specific provisions.

5. Downloading Documents

1. Open the document you wish to download.
2. Click the **Download** button.
3. Save the document to your device.

1. Log in to your account.
2. Navigate to **My Account** or **Subscription**.

 - Activation Date
 - Expiry Date
 - Payment Status

Renew Subscription

1. Select **Renew Subscription**.

 3. Complete the payment process.
 4. Upload payment confirmation if required.
